Board of Education

The five members of the Board of Education are nominated by petition and elected at the regular November election. Two Board members are elected in one election and three are elected two years later. All Board members are elected to four-year terms.

A majority of the members of the Board of Education constitutes a quorum.

The Board of Education meets during the first 15 days of January each year and elects one of its members as president and another vice-president. Both officers serve for one year.

The Board has responsibility for policy-making according to state law, representing the State of Ohio and West Branch Citizens in all matters and decisions dealing with public education; acting in a nonpartisan and nonsectarian manner; and acting as a committee-of-the whole, with no member having authority to speak independently for the Board.

The Superintendent serves as the chief administrative and executive officer of the school district. In this capacity the Superintendent is responsible for advising the Board of the needs, problems, and programs of the district. The Superintendent's recommendations on a matter normally precede Board actions.

The Treasurer is appointed by the Board to maintain all financial records relative to the collection and expenditure of funds and, along with the Superintendent, serves as financial advisor to the Board.

Meetings

The Board of Education regularly meets on the third Thursday of each month at 7:30 p.m. in the West Branch High School Media Center, 14277 Main Street, Beloit, OH 44609.

Special meetings are held at other times for school matters which need the Board's attention. Notices of all meetings and Board agendas are given to local newspapers and are posted in the offices of the schools.

All Board meetings are open to the public, and representatives of the news media are invited to attend.

Executive Sessions

The Board, under Ohio law, may hold executive sessions during the meetings to discuss (1) personnel matters, (2) purchase of property for public purposes, (3) pending or imminent court action, (4) negotiations with employees, (5) matters to be kept confidential by federal law or state statutes, and (6) specialized details of security arrangements. Executive sessions are for discussion. The Board is not permitted to take any action.
